NOTIFICATION

In supersession of this Department Notification No. 26912-27062 dated 28<sup>th</sup> October, 2015 and in exercise of powers vested in me vide Clause 3(1) (a) of the Himachal Pradesh Hoarding and Profiteering Prevention Order 1977, I, Priyatu Mandal, IAS, Director, Food, Civil Supplies & Consumer Affairs, Himachal Pradesh, do hereby fix the maximum quantity that may at any time be possessed by a dealer in respect of entry no. 4 i.e. pulses in Schedule-I appended to the order (ibid) as follows:-

**Pulses (for all pulses taken together): 150 quintals**

This revised stock limit shall, however, not apply to wholesale/retail outlets of PSUs such as HP State Civil Supplies Corporation and cooperative institution such as District Federations and Tehsil Unions dealing in pulses.

Retail chains and other dealers having multiple branches under the same ownership dealing in foodgrains across the State shall have to seek a separate license for each place of business under Himachal Pradesh Trade Articles (Licensing & Control) Order, 1981.
